**OPEN AUCTION NOTICE**

The Director, ICAR-NRCP, Solapur invites all the interested firms for open auction of **Green Cavendish Bananas (Appx. Qty. 45000 Kg)** on the basis of the following conditions.

1. The open auction will be held on **22.07.2026** at 11:30 AM.
2. Interested firms wishing to participate in the auction shall deposit an **Earnest Money Deposit (EMD) of Rs. 2,000/- (Rupees Two Thousand Only)** through **online/digital mode** with ICAR-NRCP, Solapur before the commencement of the bidding process. The EMD of unsuccessful bidders shall be refunded within one week after the completion of the auction process. The successful bidder shall deposit **50% of the accepted auction amount on the same day** and the **remaining 50% within 15 days from the date of award of the auction**.
3. The successful bidder shall harvest the Green Cavendish Bananas based on their maturity from the ICAR-NRCP campus. However, all bananas must be harvested within **two months** from the date of award of the auction.
4. Interested bidders may inspect the bananas before participating in the auction on any working day (Monday to Friday) between **11:00 A.M. and 4:30 P.M.** at the premises of the Centre.
5. Harvesting of bananas shall be permitted only on working days (Monday to Friday) between **10:00 A.M. and 4:00 P.M.**
6. Before removing the harvested bananas from the campus, the successful bidder shall obtain a gate pass from the **SAO/Farm In-charge**.
7. The successful bidder shall arrange his own labour, equipment, transportation, and all other resources required for harvesting and transportation.
8. ICAR-NRCP, Solapur shall not provide any assistance or support for harvesting, loading, transportation, or related activities.
9. After the auction is finalized, the Centre shall not be responsible for any loss of or damage to the auctioned bananas.
10. Any applicable taxes, duties, levies, or statutory charges shall be borne and paid by the successful bidder.

11. The successful bidder shall not be permitted to sell the harvested bananas within the ICAR-NRCP campus.
12. ICAR-NRCP, Solapur shall not be responsible for any accident, injury, or incident occurring during the harvesting, loading, or transportation of the bananas.
13. Any bidder who fails to comply with the instructions of ICAR-NRCP officials or creates any nuisance or disturbance may be disqualified from participating in the auction.
14. Once the auctioned items are accepted by the successful bidder, they shall not be taken back or exchanged.
15. The successful bidder may deploy security personnel/guards for safeguarding the auctioned bananas, if required, at his own cost.
16. All expenses relating to labour, harvesting, loading, transportation, security, and any other incidental charges shall be borne by the successful bidder.
17. The Director, ICAR-NRCP, Solapur reserves the right to accept or reject the final auction amount without assigning any reason thereof.
18. The decision of the Director, ICAR-NRCP, Solapur in respect of any dispute arising out of the auction shall be final and binding on all bidders.
